## 3. Collin Williams - Wildlife Biologist

a. Oregon Wildlife foundation grant application to fund sage-grouse migration mapping Collin is requesting to submit a grant application to the Oregon Wildlife Foundation in the amount of \$4,870.00 and it will be used for Sage Grouse research in Logan Valley. It will be used to purchase 5 satellite transmitters to be place on the sage grouse, and air time for the transmitters. They want to better understand where the sage grouse in logan valley, typically they are in the Drewsey area, 10 miles away. They are looking to see why they are coming into the area and work with other agencies.
